Request to subdivide one parcel and four lots to create 147 lots and 16 parcels for up to 147 single-family attached (townhouse) units, with Waiver of distance for residential roads paralleling railroads per Section 50.4.3.E.1.f

**B. Site Plan No. 820220180**

Request to construct 147 single-family attached (townhouse) units with 15% MPDUs and associated site features.

**Located** on the south side of Manor Road, approximately 50 feet west of its intersection with Jones Bridge Road.
