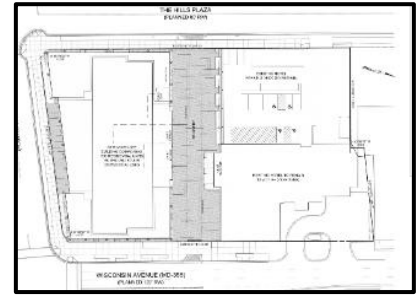

# PLANNING BOARD HEARING

On, **April 13, 2023**, the Montgomery County Planning Board will conduct an in person and virtual public hearing at 2425 Reddie Drive, Wheaton, Maryland on the following development plan:



**Name of Plan:** 5500 Wisconsin

**Zoning:** CR-3.0 C-2.0 R-2.75 H-90T

**Property Size:** 1.81 Acres

**Master Plan:** 1998 Friendship Heights Sector Plan

**Proposed Use: A. Sketch Plan Amendment No. 32022001A** – Request to amend previous Sketch Plan approval to revise previously proposed density figures and to include a transfer of up to 32,718 square feet of density from a neighboring property through the FAR Averaging allowance of the Zoning Ordinance, for a total of up to 446,478 square feet of density. Additional modifications include an update to the previously approved public benefit points and categories.

**B. Site Plan No. 820230040** – Request to develop a mixed-use building, with an average height of up to 90 feet (maximum tower height of up to 187 feet), comprised of up to 308,118 square feet of multi-family residential uses for a maximum of 300 units with 15 percent MPDUs, and up to 136,487 square feet of commercial uses (existing 125,472 square feet of hotel to remain), for a total Site density not to exceed 444,605 square feet.

Located at the northwest quadrant of the intersection of Wisconsin Avenue and South Park Avenue.
